- I. **BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF FOREST PARK, OKLAHOMA** that for the purpose of electing Officers of the said Town that a nonpartisan general election shall be held on **Tuesday, April 4, 2023, at the Forest Park Town Hall from 7:00 a.m. to 7:00 p.m.**
- II. **BE IT FURTHER RESOLVED** that the filing period for electing Officers of the Town of Forest Park shall begin at **8:00 a.m. on Monday, February 6, 2023, and close at 5:00 p.m. on Wednesday February 8, 2023.**
- III. **BE IT FURTHER RESOLVED** that the Officers of said Town to be elected are **nominated by ward and elected at large.**
- IV. **BE IT FURTHER RESOLVED** that the following Officers will be elected for four-year unexpired terms:

- VI. **BE IT FURTHER RESOLVED** that absentee ballots will be provided in accordance with Oklahoma State Law.
